Information clause on processing of personal data

Under Regulation (EU) 2016/679 of the European Parliament and of Council of 27th April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data and repealing Directive 95/46/EC (GDPR):

1. The Administrator of personal data of all persons entitled to use Advertising and promotional materials as part of the cooperation with Polychem Systems Sp. z o.o. under art. 4.7 GDPR is Polychem Systems Sp. z o.o.
2. Direct contact details are available on www.polychem-systems.com.pl under the tab "Contact."
3. The Administrator has appointed a Data Protection Officer who can be contacted via the following address e-mail: iod@polychem-systems.com.pl or by direct correspondence to the Administrator's address.
4. Personal data shall be processed in accordance with the provisions of the GDPR and the provisions of the Polish law, and to the extent consistent with the information provided in the *Application for access to Advertising and promotional materials*.
5. The processing of personal data shall take place: on the basis of the Customer's consent (Article 6.1.a GDPR) exclusively for the purposes of: transfer of advertising and promotional materials, exchange of necessary information, monitoring of adherence to *the Terms of use of advertising and promotional materials provided as part of cooperation with Polychem Systems Sp. z o.o.*, as well as for the purposes resulting from legally reasonable interests of the Administrator.
6. Personal data shall be processed for the period necessary to fulfil the purposes indicated in sec. 5. Personal data shall be processed until the withdrawal of consent, with consideration of the period of limitation of possible claims under the applicable law, in particular the Civil Code.
7. In connection with the processing of personal data, the customer shall have the right to:
 - a. access to their personal data,
 - b. rectification of their personal data,
 - c. request the processing of their personal data be restricted or their personal data be deleted,
 - d. withdraw the consent for the processing of personal data at any time, and the withdrawal of consent shall not affect the lawfulness of processing on the basis of consent before its withdrawal.
 - e. object to the processing of their personal data at any time on the grounds relating to the particular situation, where the processing is performed for purposes resulting from legally reasonable interests of the Administrator (Article 21.1 GDPR) or relating to direct marketing (Article 21.2 GDPR),
 - f. request the transfer of personal data processed for the conclusion and performance of a contract or processed on the basis of consent,
 - g. file a complaint with a supervisory body (the Head Protection of Personal Data Office) if it is considered that the processing of personal data violates the provisions of the GDPR. 8. Recipients of personal data are:
 - a. law firm,
 - b. entities supporting the Administrator in the maintenance of the IT systems.
9. The data provided shall not be transferred outside the European Economic Area (EEA).
10. The provision of personal data is voluntary, but necessary in order to use the Advertising and promotional materials provided as part of the cooperation with Polychem Systems.
11. Personal data is obtained directly as a result of submitting an Application for access to the Advertising and promotional materials provided as part of cooperation with Polychem Systems Sp. z o.o.
12. Personal data is not subject to automated decision-making, including profiling.
